PANELTIM NV REACH STATEMENT

Dear,

As a manufacturer of artificial material products for various industrial applications, we would like to inform you with this statement about the position of Paneltim nv regarding the REACH (Registration, Evaluation, Authorisation and restriction of Chemicals) regulations. We are currently in compliance with REACH. We will continue in our efforts to follow up on the further developments within the REACH regulations and ensure conformity on a permanent basis.

According to the REACH regulations, Paneltim nv can be regarded as the manufacturer of objects". In order to manufacture these "objects", we use "chemicals" and "preparations", in particular additives and dyes.

As a downstream user of the dyes and additives, we are not responsible for the (pre)registration of these chemicals, or for the risk analysis.

We only work with European suppliers and importers. We have informed them about the applications for which we use their products and pointed their obligations in relation to the REACH regulations out to them. We also work closely with our suppliers to monitor their progress and measures relating to REACH conformity.

An inventory of our dyes/additives enables us to react quickly to any change in the supply chain. Each newly bought dye/additive is examined based of the REACH Regulations. If it appears that some chemical substances or preparations are not pre-registered, or registered by our suppliers, alternate registered chemicals will be used.

Because there is no question of intended release of the chemical substances from our "objects" and that these mainly consist of polymeric materials (polyolefins: PP and PE), our "objects" are exempted from registration.

The European Chemical Agency (ECHA) publishes a candidate list (http://echa.europa.eu/chem_data/candidate_list_table_en.asp) regularly (+/- six-monthly) of substances of very high concern (SVHC). We adhere to this list meticulously. Should it appear that our "object" contains any such ingredient, we will inform our customers and immediately start looking for an alternative solution.

We can hereby inform you that such substances are not used, based on our current knowledge and that of our suppliers.

We are confident that we have informed you about our REACH approach. We are therefore confident that our statement provides an answer to all your questions and concerns regarding REACH in the context of our cooperation. In any case, you can always contact us for any additional questions.
